Please note that the items supplied shall meet the requirements of POWERGRID Specifications/ Approved Drawing/ Data Sheets/ GTP/MQP, relevant IS standards and project specific type tests. Manufacturer shall ensure that the above documents are available at the works so that proper inspection is carried out without delay. If, at any point of time, any abnormality is noticed in this regard, we reserve the right to increase our involvement by way of additional inspection and/or additional customer inspection points (CIP) at any stage or withdraw this approval with immediate effect.

### Special Remarks:

#### For Hardware Fitting Components:

- All forged and galvanized components procured from M/s Leonsmith shall be traceable from raw material to finished goods and parts shall have vendor marking (Leonsmith) and customer marking (Legion Energy).
- M/s Legion shall carry out the incoming checks on the components in line with the Technical specification/MQP.
- All components shall be marked with month and year marking.

#### For Metal End fittings for CLRI

- M/s Leonsmith shall carry out forging and galvanizing only. It shall be ensured that machining is carried out from approved vendors.
- Chemical testing on samples shall be carried out at third party laboratory till the time Spectrometer and other related machines are procured and installed at the works of M/s Leonsmith.
- In case, no POWERGRID order is executed for more than two years, further extension shall be accorded / considered only after process audit of your works.
